Fixed Issues

- Fixed the issue that some operations may fail on January 1st.
- Fixed the issue that if the linked facial recognition schedule of the face group is deleted already, the face group still cannot be deleted and prompted it is linked with a recognition schedule.
- Improve the accuracy of License of asw.
- Fixed the issue that history video copyback may fail for ISUP cameras.
- Fixed the issue that when importing keyboard control IDs in System Configuration > Video Surveillance > Keyboard Control ID, if there are more than 100 IDs, the importing will fail.
- If the camera has been configured with recording schedule stored in central or on encoding device, after disabling the camera recording schedule, the device is still recording.
- Optimized the operation that in System Configuration, when selecting a vehicle owner from the person list for the vehicle, users can click the person name to select.
- Fixed the issue that applying fingerprints to face recognition terminal (DS-K1T607 series) may fail.
- Fixed the issue that when adding a DeepinMind series NVR, if it prompts that the password is incorrect, after entering a correct password and saving, the platform cannot match with the drivers of the device.
- Fixed the issue that when adding a guidance terminal, if it prompts that the password is incorrect, after entering a correct password and saving, there will be duplicate channels in the device details page.
- Fixed the issue that the platform cannot receive the face recognition event from the devices when there are more than 1000 cameras managed in the platform.
- Fixed the issue that when applying facial recognition schedule to Facial Recognition Server (Pure Analysis), if it detects that one face is abnormal (such as blurred face), after deleting this face from the face group, it still prompts that applying recognition schedule to device failed.
