Chapter 2 What's New

2.1 Device Management

Supports adding devices of which the port No. is 80.

2.2 Person

2.2.1 Added Feature

- 1. When exporting person information, the user name and password of the super user will be required for verification.
- 2. When exporting face pictures, the user will be required to set an encryption key for security reasons.

2.2.2 Updated Feature

On the Person Management page, the Export button is hidden by default. To display and use this function, go to **System Configuration** -> **General** to enable the Export Person Information function.

2.3 System Configuration

The General page supports enabling or disabling the Export Person Information function. If you enable this function, a message noting information security will prompt and the Export button will be displayed on the Person Management page.

Chapter 3 Resolved Issues

The following are issues resolved in this version.

No.	Issue Description		
1	Loading the Remote Configuration page of KD8003 door station failed.		
2	After importing the configuration files of V1.5.0 to V1.6.0, the person information on the client is lost.		
3	On the client in other languages (excluding English), after applyin person room No. to devices, the failure of getting person information occurs, and the person information cannot be displayed.		
4	When multiple card readers (of which some does not support authenticating via fingerprints) are managed by a 26-series access controller, the failure of applying person information to the card readers occurs.		

Chapter 4 Known Issues

Issue:

For client in other languages, the Export Person Information button will be displayed in English.

Solution:

The packages in other languages will be published later.
