5 Quick Start

1 Set Language

- After the device activation, you can select a language for the device system

You can select the time zone according to actual needs. Tap Skip to skip time zone settings. Tap PREVIOUS to go back to language settings. Tap NEXT to set network

Set Network

- Select the network type as Wired or Wireless from the drop-down list according to actual needs.
- Tap Skip to skip network settings
- Tap Next to complete quick start settings.
- Tap PREVIOUS to go back to time zone settings.

Tips When Collecting/ Comparing Face Picture

Expression

- Keep your expression naturally when collecting or comparing face pictures, just like the expression in the picture on the right.
- Do not wear hat, sunglasses, or other accessories that can affect the facial recognition function.
- Do not make your hair cover your eyes, ears, etc. and heavy makeup is not allowed.

Posture

In order to get a good quality and accurate face picture, position your face looking at the camera when collecting or comparing face picture.



Size

Make sure your face is in the middle of the collecting window.
